Re: Request for Access to Information under Part II

of the Access to Information and Protection Privacy Act

File: PB/26/2016

On January 12, 2016 the City of St. John's received your request for access to the following information:

""Information regarding City Council's decision to permit a music concert to take place on July 11/2015, in the field south of the Confederation Building and adjacent to residential properties located on Gooseberry Lane, Shea Street and Osbourne Street, including any subsequent council matters arising from the concert. The information requested includes the costs incurred by the City and matters addressed at special or privileged meetings of council that were not ratified by the city council according to the requirements outlined in the Municipalities Act."

Enclosed is the information you requested with the exception of "matters addressed at special or privileged meetings of council that were not ratified by the city council according to the requirements outlined in the Municipalities Act." The City of St. John's is regulated by the City of St. John's Act and not the Municipalities Act. Any information discussed at a special meeting of Council is not subject to disclosure pursuant to section 28(1)(c) of ATIPPA, 2015 which states:

Local public body confidences

- **28.** (1) The head of a local public body may refuse to disclose to an applicant information that would reveal
- (c) the substance of deliberations of a meeting of its elected officials or governing body or a committee of its elected officials or governing body, where an Act authorizes the holding of a meeting in the absence of the public.

Section 40 of the City Act authorizes special meetings of Council and Section 41(1) states that minutes of these meetings are not subject to disclosure.

Special meetings

40. Special or privileged meetings of the council may be called at the times that the mayor may consider necessary, or on the written request of 3 members of the council.

Minutes to be public

41. (1) Ratepayers may obtain a copy of minutes of the council other than minutes of a special or privileged meeting on written application.

Chris Pitcher, Supervisor with Parking Services has advised that 5 Parking Enforcement Officers (PEO's) were assigned to work on July 10, 2015 as a result of the Confederation Hill concert. They worked a total of 56 hours at a cost to the City of St. John's of \$2,833. These PEO's were assigned to enforce parking restrictions put in place by the City in the immediate neighboring residential area. The restrictions and their enforcement ensured there was no congestion in the area allowing emergency vehicles to retain full access to the neighborhood.

All costs associated with traffic control on the Parkway the Confederation Building parking lot and set up of the concert site itself were at the expense of the promoter.
