






Economic Growth and Oil Production



Overall real GDP growth in the St. John's CMA fell primarily due to lower offshore oil production in 2023. Excluding oil and gas, the economy eked out 0.1% growth. In 2024, real GDP is projected to increase 3.2% due to higher oil production.

Real GDP Growth With and Without Oil & Gas St. John's CMA (%)









Housing Starts

Housing starts decreased by 33.4% to 488 units in the metro region in 2023. In the City of St. John's housing starts decreased to 241 units.

For 2024, housing starts are projected to increase 39.6% to 681 units.

Housing Starts - City of St. John's and St. John's CMA 2013 - 2023





Benchmark Composite Actual MLS® housing prices in December



Industrial market rental rates increased to \$16.54 per sq. ft in the first quarter of 2024. The vacancy rate increased due to an addition of industrial space in the market.





First Quarter Overall Avg. Asking Rent St. John's 2014 - 2024





1st Quarter Office Market Overall Vacancy St. John's CMA (%) 2014 - 2024





Building Permits



The total value of building permits in the City of St. John's decreased -1% to \$213 million in 2023. The value of residential permits increased by 28.0% to \$97.6 million in 2023. As of May 28, 2024 the total value of building permits has increased 115% to \$147.7 million.








St. John's CMA labour force participation rate decreased 2.4 percentage points to 65.1% in 2023 on par with the national rate **(65.6%).**




Average Weekly Earnings





Age Distribution












Consumer Insolvencies






Out of Province Student Data



Passenger traffic increased 17.4% in 2023 compared to 2022, still below pre-pandemic 2019 levels.

Airline Passenger Movements at St. John's International Airport 2013 - 2023 (000's)





- The St. John's CMA economy is expected to grow by 3.2% in 2024.
- Oil production is expected to rebound as the Terra Nova FPSO experiences its first full year of production.
- Rising population levels and spinoff effects from increased oil production and rising construction activities will increase economic activity in many service sector industries.
- Inflation remains sticky; driven by accelerating inflation in 'Shelter' and 'Transportation'.
- Housing starts are projected to rebound.
- Shift to a balanced housing market.
