Eligibility Criteria and Nomination Requirements	SECTION 1

The City of St. John's Volunteer Awards recognize residents in 2 categories: Individuals (aged 19 plus) and a Community Group who have volunteered their time to make our city a better place for all to live, work, learn and play.

Eligibility Criteria:

- Nominees fall under two categories: Individuals (aged 19 plus) and a Community Group.
- Nominee(s) must be a resident of the City of St. John's.
- All achievements reflected in the nomination must be voluntary/unpaid in nature.
- The volunteer service must improve the quality of life and well-being of citizens based on their contribution to one or several **'Healthy Community'** categories:
 - Healthy Neighbourhoods and People
 - Environment and Sustainability
 - Inclusion
 - Social and Community Connections
 - Transportation
 - Housing
- Previous award recipients are not eligible for nomination.

Nomination Requirements:

- Nominator must discuss and receive approval from the nominee, to avoid multiple nominations for one individual.
- Submission of fully completed nomination form by nominator.
- One reference letter from someone other than the nominator. This cannot be a member of the Nominee's immediate family.
